

# Official Rules (Register-to-Win )

**1. Sponsor**

Young Men's Christian Association of Greater Charlotte, a North Carolina nonprofit corporation, 400 E. Morehead St., Charlotte, NC 28202 ("Sponsor").

**2. Eligibility**

Open to legal residents of North Carolina who are 18 years of age or older at time of entry. Employees, contractors, board members of Sponsor, and members of their household are not eligible. Void outside NC and where prohibited.

**3. Promotion Period**

Begins 8/25/2025 and ends 10/3/2025 ("Promotion Period"). Sponsor's clock is official.

**4. How to Enter**

a) **Online:** Complete membership application at [Membership | YMCA of Greater Charlotte](#) during the Promotion Period.

b) **Mail-in :** Hand-print your full name, mailing address, phone, and email on a 3"x5" card and mail in a stamped envelope to: "Ultimate Center Experience Entry," 400 E. Morehead Street, Charlotte, NC 28202 Attn: Marketing Department. Must be postmarked by 10/3/2025 and received by 10/7/2025.

Limit (maximum of two) entries per person for the promotion period, regardless of method. All methods have equal chance to win. Incomplete, bulk, or automated entries are void.

**5. Drawing and Odds**

Sponsor will conduct a random drawing on or about 10/10/2025 from all eligible entries received. Odds depend on number of eligible entries.

**6. Prizes**

Sponsor reserves the right to disqualify any individual who tampers with the entry process or violates these Rules, and to cancel, modify, or suspend the promotion if fraud, technical failures, or any factor impairs the integrity or proper functioning of the promotion, as determined by Sponsor.

By entering, participants agree to release and hold harmless Sponsor and its directors, officers, employees, and agents from any claims or liability arising from participation or acceptance/use of any prize to the extent permitted by law.

**12. Disputes/Governing Law**

All issues and questions concerning the construction, validity, interpretation, and enforceability of these Rules, or the rights and obligations of entrants and Sponsor, are governed by the laws of the State of North Carolina, without regard to conflict of law rules. Venue lies exclusively in the state or federal courts located in North Carolina.
